<b>Introductions:</b> Jessica Humphrey, Director of Community Development,  STEPS Forward Sylvie Zebroff – Family Partnership Advisor, CLBC	<b>Presentation by Jessica Humphrey, STEPS Forward</b> <ul style="list-style-type: none"> <li>o It is becoming a growing priority for families that full inclusion for their child continues beyond the Kindergarten through Grade 12 years. STEPS Forward provides opportunities for individuals with developmental disabilities to participate in post secondary education programs in the same way that their peers often choose. Currently students are attending programs at UVic, UBC, Emily Carr University of Art and UBC (Okanagan Campus).</li> <li>o The idea of STEPS Forward is that each individual would follow the natural dynamic of regular student life. Their experience should parallel the undergraduate experience. This includes auditing classes, participating in co-op programs, building peer relationships, participating in campus life and finding meaningful summer employment. Inclusive post secondary education is viewed as the jumping off point to the next step in adult life.</li> </ul>

- The mandate of STEPS Forward is that relationships be built with post secondary institutions, and that support required for each student to succeed be “embedded” within the post secondary environment. A large part of their work is “building the capacity of the community”, so that support from STEPS staff can fade out and be replaced by natural supports such as professors, other students, librarians, recreation centre staff, etc.
- STEPS Forward has been in existence for 10 years, and has been funded primarily by the Ministry for Advanced Education, with grants and fundraising filling funding gaps. Funding is an ongoing concern, and they are currently working towards a joint initiative between CLBC and the Ministry of Advanced Education. Pilot projects with CLBC are new this year.
- Emphasis continues to be placed on focusing on outreach and building relationships with other institutions. Michael Hayes expressed an interest in assisting to establish a relationship with Simon Fraser University.
- A handout was provided and can be found in the meeting minutes binder.
- A video presentation, based on inclusive post secondary education in Alberta, was shown.

**Presentation by Sylvie Zebroff, Family Partnership Advisor, CLBC:**

- The impetus behind Sylvie’s position is to help CLBC become more family friendly and build families’ resilience and capacity. She serves as a bridge between families and CLBC.
- Sylvie meets with families, councils, managers and staff – observations from these parties helps CLBC to identify successes, barriers and areas requiring improvement.
- Themes/areas requiring attention that have been identified include: 1) the transition process for individuals moving from their teenage to adult years, 2) the Personalized Support Initiative (PSI) – eligibility, 3) planning – how to do this best, 4) senior parents – what do their support needs look like?, 5) regional issues – what are other families, councils, etc doing?
- On Wednesday, March 17<sup>th</sup> Sylvie and Shelley Nessman (CLBC Self Advocate Advisor) are facilitating an event entitled “You , Me and CLBC”. It will take place at the UVic Faculty Club at 6:30 pm. They will provide information as to what CLBC does and opportunities for discussion and networking.

	<ul style="list-style-type: none"> <li>○ Sylvie’s quarterly report, in which she will identify themes and ideas that she has been hearing from different communities, will be available through a link on the CLBC website. Bill suggested that it would be beneficial to have a section on the CLBC website that is specifically for families.</li> <li>○ In regards to information sharing, Michael noted that it would be helpful to meet with other community council members. Stephen Russell, who will be attending the next SICC meeting, was identified as someone who may be able to assist in this process.</li> </ul>

CLBC Staff Reports	<p><b>Lesley Lambert, Manager Community Planning &amp; Development</b></p> <ul style="list-style-type: none"> <li>• David McPherson, Brian Salisbury and Lesley attended a Second Wave meeting (Transition Group lead by Arlene Zuckernick &amp; Catriona Johnson) – it was an excellent meeting and well attended.</li> <li>• Personalized Support Initiative (PSI)- at this point six individuals have been confirmed eligible, which is the highest number in the province. More referrals are coming in all the time.</li> <li>• At the last meeting Bev had commented that profiles included in the PSI handout misrepresented people with FASD. Bev has since spoken with Jacinta Eni and these profiles will be rewritten once “real life” examples can be taken from individuals receiving support through PSI.</li> <li>• Lesley is unable to attend meetings in March and April, but another CLBC representative will attend in her place.</li> <li>• WOW! CLBC Recognition Award – WOW stands for “Widening our World”. This award is given to individuals who have done exceptional things to foster “good lives in welcoming communities”. Lesley asked the community council for support in nominating individuals for the award and/or being part of the selection committee. Awards will be given in four areas: self advocate, family member, community partner and service provider. The nomination form can be found on the CLBC website under “What We Do” and nominations will be accepted until April 4, 2010. The awards will be presented at a regional forum in May 2010. Bev indicated that she would like to be part of the selection committee.</li> </ul>

- Spring planning session – it is suggested that a significant amount of time at our upcoming planning session be dedicated to exploring ways to make our Councils and PAC more strategic. A review of our recently changed Terms of Reference for both may be in order.
- March 30<sup>th</sup> Meeting – Stephen Russell has been invited to attend and address the new landscape in terms of board relationships with both PAC and Councils.
